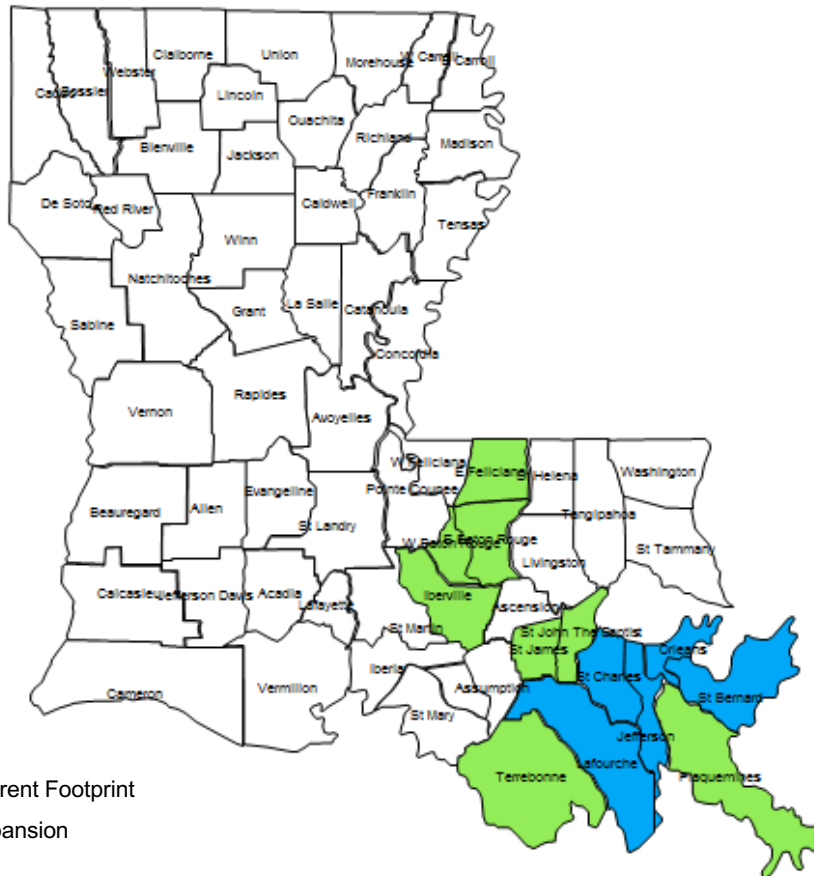

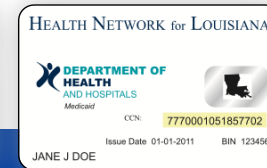
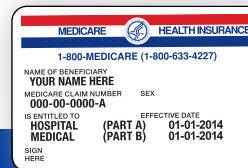

	Vision	●	Annual exam and \$300 credit every year for eyewear
